- Popular industry expert Miriam Lieber will host a session titled "Revenue Cycle Management - Where Do I Fit In?" She

will delve into the revenue cycle, focusing on ways to increase accountability, maximize efficiencies and improve process. Miriam will discuss front and back-end practices, working and resolving denials, third party nuances, people vs automation and more. This will be an engaging, candid and comprehensive view of revenue cycle management.
